Pursuant to Your Honor's Interim Order Scheduling a Further Evidentiary Hearing issued on March 15, 2019, enclosed please find three copies of National Fuel Gas Distribution's ("Distribution") pre-marked Exhibits F and G for the hearing scheduled for Tuesday, May 28, 2019.


Exhibit F contains a sample bill as well as tariff pages demonstrating the source of the charges on the sample bill. Exhibit G contains calculations showing how the margin is calculated for the customer contribution component of the revenue deficiency calculation shown on Exhibit C.

Distribution notes that it filed tariff pages pre-marked as Exhibit D on February 14, 2019. These tariff pages should not have been pre-marked as Exhibit D because there was an Exhibit D that was entered into the record at the hearing. In addition, the tariff pages that were included in Exhibit D that was filed on February 14, 2019, are included in Exhibit F which is attached hereto. For these reasons, Distribution requests that Your Honor and the parties disregard pre-marked Exhibit D that was filed on February 14, 2019. Instead, Distribution plans to request that Exhibits F and G be admitted into the record at the hearing scheduled for May 28, 2019.


