In accordance with the Interim Order issued on December 20, 2018 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). In accordance with that Interim Order, Met-Ed initiated discovery on February 22, 2019. However, Ms. Steely has yet to respond to Met-Ed's discovery. To that end, Met-Ed filed a Motion to Compel on February 22, 2019. That motion remains outstanding at this time. Further, Ms. Steely has failed to provide notification of her expert and factual witnesses in accordance with the December 20, 2018 Interim Order. Met-Ed timely provided notice of its expert and factual witnesses. Met-Ed suggests that it may be valuable for a prehearing conference to be set for this matter in order to determine Ms. Steely's intent in moving this matter forward.


