

Dear Secretary Chiavetta:

In accordance with the Interim Order issued on December 19, 2018 in the above-referenced matter, this letter serves as a status report on behalf of West Penn Power Company ("West Penn"). In accordance with that Interim Order, West Penn initiated discovery on January 15, 2019. Mr. and Mrs. Sabatini requested more time to respond to the discovery and an Order was entered on February 12, 2019, granting them until March 7, 2019 to submit objections and March 14, 2019 to submit full and complete responses. However, Mr. and Mrs. Sabatini did not timely object to any part of the discovery and only partially responded to West Penn's discovery, in contradiction to the Order entered February 12, 2019. As a result, West Penn filed a motion to compel on April 23, 2019. That motion remains outstanding at this time. Further, witness identification has been made by West Penn, yet Mr. and Mrs. Sabatini have failed to provide notification of their expert and factual witnesses in accordance with the December 19, 2018 Interim Order. West Penn suggests that it may be valuable for a prehearing conference to be set for this matter in order to determine the Complainants' intent in moving this matter forward.


