**SILVER VALLEY APARTMENT'S REPLY TO ANSWER OF PPL ELECTRIC UTILITIES
CORPORATION**

TO: ROSEMARY CHIAVETTA:

Silver Valley Apartments hereby replies to Answer Of PPL Electric Utilities Corporation:

1. Regarding paragraph 4 of PPL's answer, PPL is lying through it's teeth. PPL is trying to avoid the 4 year limitations and latches by transferring a debt that is originally 7 years old as set forth in the PUC's decision. Even though the transfer to this account is less than 4 years old, the disputed amount is 7 years old. PPL cannot do this because of limitations and latches. Therefore, Silver Valley Apartments denies the transfer is valid.
2. Regarding paragraph 5 of PPL's answer, we stand on our reply of paragraph 1 above.
3. PPL continues to sneakily tack the disputed amount from 7 years ago onto our current bill without explanation. Please see exhibit A.

WHEREFORE, Silver Valley Apartments requests the PUC to:

- a) order PPL to stop billing Silver Valley Apartments for the disputed amount or trying to collect it.
- b) Assess the maximum fine against PPL.

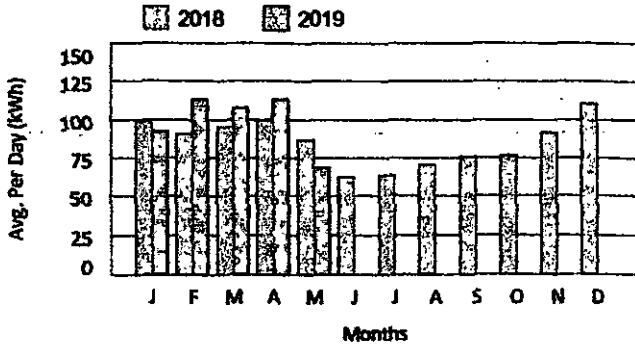

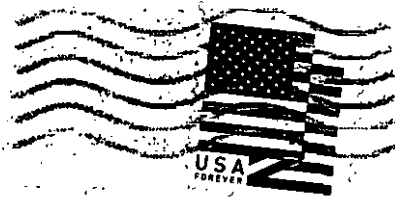
