Dear Secretary Chiavetta:

In accordance with the Interim Orders entered on October 18, 2018 and March 13, 2019, Metropolitan Edison Company ("Met-Ed") has completed its discovery in this proceeding. However, Mr. and Mrs. Mosley have failed to provide notification of their expert and factual witnesses. Witness identification has been made only by Met-Ed. - *Page 1 question # 2. I answered I do not have any witnesses - so I can't give you identification.*

Additionally, in accordance with the Interim Orders issued on March 13, 2019 and March 25, 2019 in the above-referenced matter, Met-Ed has been unable to reach Mr. and Mrs. Mosley regarding available dates for the scheduling of the two consecutive days of evidentiary hearing as their telephone number is no longer in service. *(You were given my new telephone # in Dec. 2018 like everyone else - I can't help if you don't correct it)*

At this point, Met-Ed recommends that a prehearing conference be set so as to ascertain the Complainant's intent in presenting witnesses at an evidentiary hearing in this matter, as well as to make certain revisions to the procedural schedule in anticipation of evidentiary hearings.
