MOTION FOR CONTINUANCE OF HEARING


Pursuant to 52 Pa. Code § 1.15(b), Philadelphia Gas Works (“PGW”), hereby submits this request for a continuance of the hearing in this matter, which is scheduled for Wednesday, May 29, 2019. In support of its motion, PGW states as follows:

1. By Notice dated April 22, 2019, the Commission scheduled an In-Person Hearing in this matter for Wednesday, May 29, 2019 at 10:00 a.m., before Administrative Law Judge Eranda Vero.
2. A PGW witness, Ms. Nashira Ramos, is unavailable as she is on maternity leave. Ms. Ramos is expected to resume her duties at PGW as of July 1, 2019.
3. Ms. Ramos is the PGW employee who visited the property in question and determined that there was a foreign load.


