

I have received copies of communications sent to her in the past, but obviously not everything is copied to me. She is very upset and feels that she is being picked upon because of her medical condition.

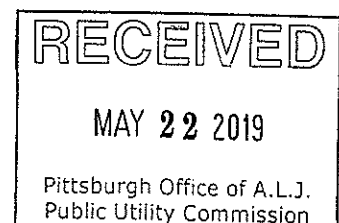
