But being new to the roll back business I didn't know what I might get in to. And I wanted to be legal if I did. But after a little over a year I realize the rollback was not what I want to do.

I am sorry that I did not telling PUC that I sold my rollback. I have no other vehicle that I run under the PUC number. So that is why I cancel my insurances (liability and cargo). So please do cancel my PUC number


I am now wondering what more I have not done. I try to do what is legal in my business. But I felt that if I didn't renew the PUC number I would be canceled from my authority.
