



PECO is aware that CSD Energy Advisors, LLC has applied for a license to provide brokering and consulting services to commercial and industrial customers on the distribution system of PECO.

In making such an application, CSD Energy Advisors, LLC could be required to provide to PECO a bond or other acceptable financial security in an amount that PECO determines to be appropriate. CSD Energy Advisors, LLC has indicated that it intends to provide only brokering and consulting services to commercial and industrial customers, and will not take title to any delivered natural gas; nor will accept any customer payments or deposits. Therefore, PECO has determined at this time that CSD Energy Advisors, LLC does not need a bond or other financial security requirement, since they are not directly engaging in business with PECO and only providing brokering or consulting services to PECO customers. However, if the services provided by CSD Energy Advisors, LLC the creditworthiness requirement for PECO's exposure to CSD Energy Advisors, LLC changes in the future, PECO reserves the right to require CSD Energy Advisors, LLC to provide a bond or other financial security instrument.

Based on your assertion that CSD Energy Advisors, LLC ("CSD") is applying with the State of Pennsylvania to operate as a natural gas broker/marketer, UGI Utilities, Inc. ("UGIU") has concluded that CSD will not need to post security with UGI Utilities, Inc. – South Rate District ("UGI South"), UGI Utilities, Inc. – North Rate District ("UGI North") or UGI Utilities, Inc. – Central Rate District ("UGI Central"). 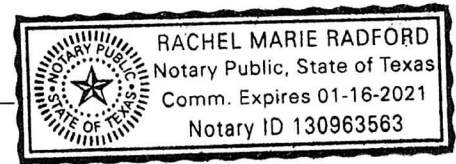

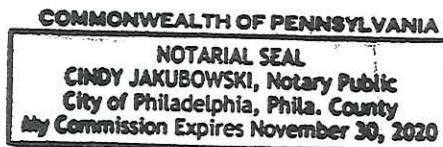
