

Subject to Notes 1 to 9 below, the transportation charges on any shipment shall be a <u>COMBINATION</u> of the applicable <u>TRAVELING CHARGE</u> named in Column 1 plus <u>HOURLY CHARGE</u> at applicable rates named in Columns 2, 3, and 4.

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days, or periods of days, as indicated, during which services are performed.

NOTE 3 - Hourty rates (Columns 2, 3, and 4) computed in quarter-hour periods; fractions of one-quarter hour considered as one-quarter hour.

NOTE 4 - When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

NOTE 5 - Applicable travel charge will be determined based on the distance from terminal to either the origin or destination of shipment, whichever is further. For distances 0-10 miles, One (1) hour; for distances 11-15 miles, One and one-quarter (1.25) hours. For distances 16-20 miles, One and one-half (1.5) hours; for distances 21-25 miles, Two (2) hours; for distances 26-30 miles, Two and one-half (2.5) hours; and for distances 31-40 miles, Three (3) hours.

NOTE 6 - Minimum transportation charges: Sundays and Holidays: four (4) hours at rates named in Column 2 plus applicable travel charge. Weekdays and Saturdays: three (3) hours at rates named in Column 3 and 4 plus applicable travel charge.

NOTE 7 - Waiver of minimum charges - Carrier Convenience: Carrier shall not assess a minimum charge (number of hours) whenever a moves requires less than the minimum number of hours filed and said move is performed solely at the carriers convenience. In such instances, the carrier shall charge based on the actual time to complete the move plus applicable travel charge.

NOTE 8 - Where service commences at the shipper after 5:00PM and before 6:00AM, rates shall be shown in Column 4.

NOTE 9 - When a plano is included in the shipment, the following charges will apply in addition to the applicable hourly rates contained herein. Spinet - \$70.00; Upright - \$90.00; Baby Grand - \$130.00; and Concert Grand - \$150.00.
