On May 10, 2019 I received a letter from Tori L. Giesler from Met-Ed regarding the status of our matter. I have 3 points in response.

1. Discovery answers to Interrogatories and Requests for Production of Documents (Set 1) to Metropolitan Edison Company were incomplete and evasive. Within 14 days I will send another set to obtain clearer answers to the questions.
2. I have NOT received the protective agreement as requested. I had requested a revision to the initial document to cover various aspects of my work experience or employer privacy. All my requests and questions have gone unanswered via email. I have also not received an updated hard copy signed by Met-Ed as suggested.
3. I decline any prehearing conference recommended by Met-Ed and prefer to proceed directly to an evidentiary hearing at the appropriate time.


