Dear Secretary Chiavetta:

In accordance with the Interim Order issued on December 20, 2018 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). Consistent with that Interim Order, Met-Ed initiated discovery on January 29, 2019. Ms. Dreher partially responded to Met-Ed's discovery and Met-Ed filed a Motion to Compel on February 14, 2019. Ms. Dreher provided additional responses and requested a protective agreement. On March 4, 2019, an Interim Order was entered which granted the Motion and directed the parties to confer regarding a protective agreement. As of the date of this report, Met-Ed has been unable to reach Ms. Dreher to discuss the entry of a protective agreement. As such, contemporaneously with the filing of this report, Met-Ed has served an executed, proposed protective agreement on Ms. Dreher.

Apart from discovery, Ms. Dreher has failed to provide notification of her expert and factual witnesses in accordance with the December 20, 2018 Interim Order. Met-Ed timely provided notice of its expert and factual witnesses.

At this point, Met-Ed recommends that a prehearing conference be set so as to make certain revisions to the procedural schedule in anticipation of evidentiary hearings.
