In accordance with the Interim Order issued on January 7, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed"). Consistent with that Interim Order, Met-Ed initiated discovery on August 20, 2018. Ms. Force responded to Met-Ed's discovery. On March 18, 2019, Ms. Force propounded discovery on Met-Ed. Met-Ed timely submitted objections to the discovery as well as responses to the questions which were not objectionable. Ms. Force filed a Motion to Compel by letter dated May 6, 2019, to which the Company filed a response on May 14, 2019. That Motion remains outstanding. To date, the parties have submitted notification of witnesses.

At this point, Met-Ed recommends that a prehearing conference be set so as to make certain revisions to the procedural schedule in anticipation of evidentiary hearings.
