On May 29, 2019, the Pennsylvania Public Utility Commission's ("Commission") Bureau of Investigation and Enforcement ("I&E") filed a letter requesting that its Protest to the above-captioned Application filed by PPL Electric Utilities Corporation ("PPL Electric" or the "Company") be withdrawn.

In that letter, I&E stated that its understanding is that PPL Electric is not seeking any ruling as part of this proceeding concerning the ratemaking treatment of the proposed transaction and that any ratemaking issues related to this transaction can be addressed in the Company's next base rate case.

PPL Electric hereby submits this letter confirming that the Company is not seeking any ruling as to the ratemaking treatment of the proposed transaction as part of this proceeding. Accordingly, PPL Electric agrees that I&E's withdrawal of its Protest is without prejudice to any parties raising ratemaking issues related to this transaction in the Company's next base rate case.


