Kindly accept this correspondence in accordance with the directives set forth in Your Honor's June 13, 2019 Interim Order Converting Initial Hearing to a Prehearing Conference and Setting Rules for the Prehearing Conference. Initially, please be advised that Respondent PPL Electric Utilities Corp. ("Respondent") has responded to Complainants Michael and Sharon Hartman's (collectively "Complainants") Request for the Production of Documents, which were served under cover letter dated May 2, 2019. Given this, Respondent will not herein specifically address Complainants' "Motion to Compel."

In addition, Your Honor requested that Respondent address Complainants' request for an in-person hearing (on site) at their property. Please be advised that Respondent objects to an in-person hearing being conducted at Complainants' property. Moreover, Complainants' claims do not present novel or complex issues, insofar as Complainants' sole claim pertains to the scope of Respondent's right-of-way on their property. Respondent will be prepared to discuss these issues further at the time of the Prehearing Conference on Wednesday, June 26, 2019.
