We are petitioning for reinstatement of our cancelled PA PUC authority.

On March 6, 2019 we immediately forwarded the original complaint notice to our insurance agent Arthur J. Gallagher. The notice included two operating entities, Page Transportation, Inc. (A-00111328) and Page ETC, Inc. (Exhibit A)

Also on March 6, 2019, Arthur J. Gallagher confirmed that the filing had been requested from the insurance company. (Exhibit B)

Arthur J. Gallagher had Hanover Insurance Company issue a Form H, the name on the Form H was Page Transportation, Inc. ETAL. And this was filed on March 21, 2019. (Exhibit C)

At this time Arthur J. Gallagher assumed that the matter had been handled and the filings complete. Per the attached e-mail dated June 26, 2019 from Arthur J. Gallagher, they believed that by including the "ETAL" on the original Form H it automatically included Page Transportation and Page ETC. (Exhibit D)

Page ETC and Page Transportation, Inc., are no longer engaging the services of Arthur J. Gallagher and have realized that this matter was not handled properly back in March 2019.

Please review the documents attached in relation to the detail of events above. We have mailed a check for \$500 to pay the required fine. We acted in good faith and believed we were doing everything necessary to be compliant with the regulations of the state of Pennsylvania.


COMPLAINT

The Pennsylvania Public Utility Commission (Commission) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement hereby represents as follows:

1. That all authority issued to PAGE TRANSPORTATION, INC., (respondent) is under suspension effective February 06, 2019 for failure to maintain evidence of insurance on file with this Commission.
2. That respondent maintains a principal place of business at 2758 TROMBLEY ROAD, WEEDSPORT, NY 13116.
3. That respondent was issued a Certificate of Public Convenience by this Commission on January 13, 1995, at A-00111328.
4. That respondent has failed to maintain evidence of Cargo insurance on file with this Commission. The Bureau of Investigation and Enforcement's proposed civil penalty for this violation is \$500 and cancellation of the Certificate of Public Convenience.


