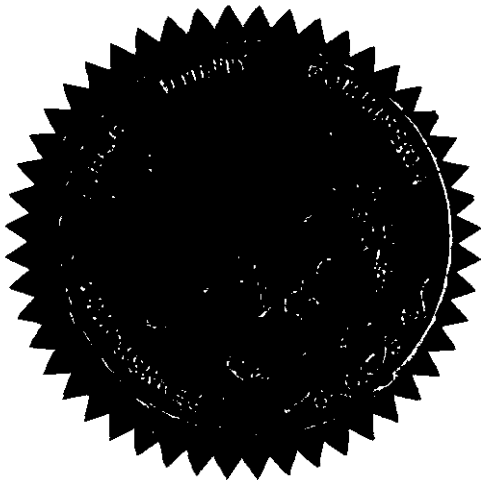

**AMENDMENT NO. 1 TO THE
AMENDED AND RESTATED OPERATING AGREEMENT
OF SPRAGUE TRANSPORT LLC (f/k/a COEN TRANSPORT, LLC)**

This Amendment No. 1 (this "*Amendment*"), dated as of April 26, 2019, to the Amended and Restated Operating Agreement, dated as of October 1, 2017 (the "*Operating Agreement*"), between Coen Transport, LLC, a Pennsylvania limited liability company (the "*Company*"), and Sprague Operating Resources LLC, a Delaware limited liability company, as the sole Member (the "*Member*") of the Company. Capitalized terms used but not defined herein are used as defined in the Operating Agreement.

RECITALS

WHEREAS, on October 1, 2017, Sprague Operating Resources LLC, acquired all of the Membership Interests in the Company formerly owned by Coen Oil Company, LLC, and thereby became the sole owner of all outstanding Membership Interests in the Company;

WHEREAS, on April 26, 2019, the Company filed a Certificate of Amendment with the Pennsylvania Department of State, Bureau of Corporations and Charitable Organizations, changing the name of the Company from "Coen Transport, LLC" to "Sprague Transport LLC";

WHEREAS, Article 10.02 of the Operating Agreement provides that the Operating Agreement may be amended by all of the Members; and

WHEREAS, the parties wish to amend the Operating Agreement to reflect the events described above.

NOW, THEREFORE, it is hereby agreed as follows:

1. Amendment.

(a) The preamble of the Operating Agreement is hereby amended and restated in its entirety to read as follows:

"Amended and Restated Operating Agreement of Sprague Transport LLC (f/k/a Coen Transport, LLC), dated effective as of October 1, 2017, between the Company and Sprague Operating Resources, LLC, a Delaware limited liability company, as the sole member (the "Member") of the Company"

(b) Section 5.02(b) of the Operating Agreement is hereby amended and restated in its entirety to read as follows:

"(b) Number of Managers. The number of Managers of the Company shall be two. The Managers of the Company shall be Joseph Smith and Robert Blanchard."

(c) Article 6.01 of the Operating Agreement is hereby amended and restated to read in its entirety as follows:

“6.01. Members. The name and address of the sole Member are:

Sprague Operating Resources LLC
185 International Drive,
Portsmouth, New Hampshire, 03801.

Additional members may be admitted to the Company in accordance with Section 3.02.”

2. Ratification of Operating Agreement. Except as expressly modified and amended herein, all of the terms and conditions of the Operating Agreement shall remain in full force and effect.
3. Governing Law. This Amendment shall be construed in accordance with and governed by the laws of the State of Pennsylvania, without regard to the principles of conflicts of law.

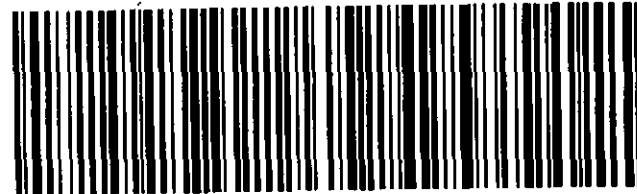
