Per Title 52 Pa. Code Chapters 1 and 5, Verde Energy USA Pennsylvania, LLC (“Verde Energy”) provides the following update to its applications:

On May 21, 2019, Robert Lane, Chief Financial Officer, resigned to pursue a new opportunity in a new industry. In the interim, Nathan Kroeker, Spark’s President and Chief Executive Officer, was appointed Interim Chief Financial Officer.

On June 3, 2019, James G. Jones II was appointed the new Chief Financial Officer. Immediately prior to his appointment as CFO, Mr. Jones served on the Board as an Independent Director and the Chair of Audit and Special Committees since 2014. Mr. Jones oversees Spark's accounting, tax, SEC reporting, treasury, financial planning and analysis, and investor relations functions. He is also the Chief Risk Officer.

Mr. Jones was a partner at Weaver Tidwell LLP, a regional certified public accounting firm. Prior to joining Weaver Tidwell, LLP, Mr. Jones was a partner in the Houston office of Padgett Stratemann & Co. from May 2014 to August 2016 when Padgett was acquired by RSM. Prior to joining Padgett Stratemann & Co., Mr. Jones was a partner at Ernst & Young LLP where he worked from October 1998 to March 2014. Mr. Jones holds a Doctor of Jurisprudence from Louisiana State University and a Bachelor of Science in Accounting from the University of Louisiana at Monroe.

Mr. Jones was appointed Chief Financial Officer because of his extensive tax and financial background, as well as his management expertise.
