
**Response:** A former manager established this rate by conducting market analysis prior to 2009. No paper file exists on the analysis. PECO has contracts with other municipalities at this rate including Philadelphia, Chester, Upland and Bristol.

Marcus Hook anticipates attaching eight (8) cameras to PECO poles. PECO anticipates revenue in the amount of \$960.00
