



**AMENDED APPLICATION OF PECO ENERGY COMPANY
TO ALTER BELOW-GRADE CROSSING AT THE
FALLS-STEEL TAP SUBSTATION BUCKS COUNTY**

TO PENNSYLVANIA PUBLIC UTILITY COMMISSION:

1. The name and address of the Applicant is PECO Energy Company, 2301 Market Street, Philadelphia, PA 19101-8699 (Applicant or PECO).

2. The Applicant is a public utility incorporated under Delaware Law and is a subsidiary corporation of the Exelon Corporation. The Applicant, *inter alia*, provides electric service in Pennsylvania as well as other states in the eastern portion of the United States. As an electric utility, PECO avers it has the corporate right to utilize the public below-grade crossing, DOT #960 641 F, between the Falls Substation and Steel Tap Substation along Bristol Pike crossing a single track of CONRAIL (the Railroad) in Morrisville Borough, Bucks County, Pennsylvania (Crossing) to enhance the quality of electric service provided to its customers in this area.

6. The Applicant estimates the cost to hang overhead fiber optic cables between the Falls Substation and Steel Tap Substation to be \$64,785 and agrees to bear all the costs incurred in furnishing material and performing the work necessary to hang fiber optic cables to serve its customers.


7. The Applicant avers it is necessary and proper for the accommodation, convenience and service of the public that PECO be authorized by the Commission to hang overhead fiber optic cables between Falls Substation and Steel Tap Substation to upgrade its facilities at the Crossing.

8. A field visit is not required.

9. The Applicant does not request a hearing prior to issuance of an order approving the Amended Application. Any hearing required to determine the final allocation of costs can be held after issuance of an order approving the project at the parties' initial cost and after completion of the work.

WHEREFORE, PECO Energy Company, requests that its Amended Application to alter the public below-grade crossing, DOT #960 641 F, so as to hang fiber optic cables between the Falls Substation and Steel Tap Substation along Bristol Pike, crossing a single track of CONRAIL in Morrisville Borough, Bucks County, Pennsylvania.
