("Lyft") has submitted a check for \$50.00, which is the fine amount requested by the Pennsylvania Public Utility Commission's ("Commission") Bureau of Investigation and Enforcement ("I&E") to terminate the above-captioned Complaint proceeding. This check was included in the package sent to the Secretary's Bureau with tracking number 736749249500. In the Complaint, I&E contends that Lyft violated Section 2605(b)(8) of the Public Utility Code, 66 Pa. C.S. § 2605(b)(8), by allegedly permitting a vehicle to operate while not having the proper Company placard displayed on the vehicle.

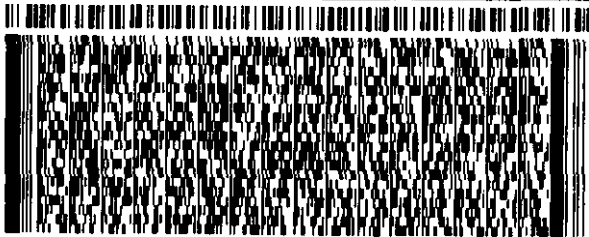

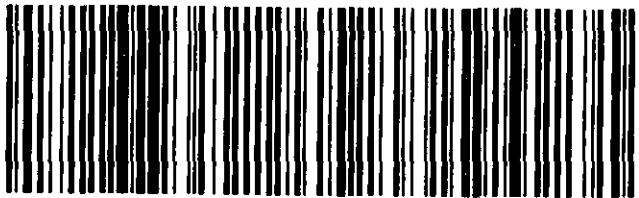
