Dear Secretary Chiavetta:

This letter is in response to a Preliminary Objection from Atty. Devin Ryan on behalf of PPL. This is concerning my formal complaint filed with the PUC in the above-referenced case. Copies will be sent to parties indicated below.

My formal complaint should be heard and is separate from another formal complaint filed for this property address (Docket # C-2018-2644957). I also own this property, currently reside at this address, and I am the person who pays this electric bill; this utility is in my name. I also have my own concerns of the safety and ill health affects of the digital "smart" meters. It is concern for my own safety and well-being, as well as that of my mother (who suffers from electromagnetic sensitivity and who can no longer be present at our property), which drove me to file my own formal complaint with this commission. I also have witnessed her decline in health since smart meters were installed in her Bethlehem neighborhood and the improvement of her condition when she would stay at this (Port Clinton) address previous to the illegal installment of a digital meter here. All of this evidence will be presented at the time of my hearing.


That is my other objection: despite my filing this formal complaint, a pending appeal on my mother's case, and advise from their attorney (Devin Ryan), PPL unlawfully installed a smart meter on my house on May 30, 2019, without notice and without my consent. I had spoken with Grid One, the company who installs these meters at the direction of PPL, only two days prior to this action; not only was I informed that a new meter would not be installed in the near future, as there was no work order for this objective, but I was promised that I would be given ample notification if such an action was planned. This is a clear violation of PA Code which states that no action should be taken pending the outcome of the dispute. We were not notified and not allowed to make a choice in the matter.

Also, I must mention at this time, I disagree with statements made in the paperwork provided me by Atty. Devin Ryan. On page 24, PPL admits that my mother has a diagnosis for her condition, known as electromagnetic hypersensitivity, from her primary physician, Dr. Stanley Yevelson. They contradict themselves on page 26 when Dr. Israel called her "self-diagnosed". In addition, my mother did in fact provide them with copies of medical reports proving this diagnosis and recommendations from her doctor to prevent a digital meter from being installed on her

properties. Although Dr. Israel disagrees with this diagnosis, he has never met, examined, or interviewed my mother, Evangeline Hoffman-Lorah, and is not qualified to overrule the diagnosis of her personal physician of more than 20 years.

I deserve my own hearing with a chance to present my evidence and testify on my own behalf. This is my legal right and should not be denied by this commission.
