The listed documents have been served upon Respondent's Counsel, Jeremy V Farrell, Esquire, verified as per 52 Pa. Code S 1.36, in accordance with Commission regulations.

These are being provided under our strongest objection, as the Complainants assert that we have more than fulfilled the Expert Witness requirements specified in the February 6, 2018 Prehearing Order to which both parties agreed, the standard applied in other Smart Meter Formal Complaints before the PA PUC, and PA Code including 52 Pa. Code § 5.324(a)(1)(ii). The task imposed on the Complainants' Expert Witnesses by the June 6, 2019 Interim Order was excessive and extreme. It imposed unreasonable annoyance, embarrassment, oppression, and burden on the Complainants, two (2) elderly people representing ourselves (with Francis Hriadil having a number of chronic conditions), in direct violation of PA Code § 5.361(a)(2); and has hindered our preparations for the scheduled August 19 and 20, 2019 Hearing, depriving us of due process.

Consequently, Michele Hriadil, due to her age, full time work commitments and responsibilities, and in light of the successive prejudicial ALJ rulings that have been made against Complainants' relevant, reasonable, and proper motions, which are inconsistent with the substance and content of those filings, and which effectively obstructed and curtailed legitimate discovery, has decided to remove herself as an Expert Witness, though she is qualified.

Copies of the three (3) Certificates of Service have also been served upon Presiding ALJ Watson, per his order.
