

Stipulation of Withdrawal of Protests is not accepted or approved by the Commission for any reason, the parties agree that the respective Protests of the Protestants shall be deemed immediately reinstated; and the respective Protestants shall have the right to (i) present evidence in an on-the-record proceeding in opposition to the Application, (ii) request reconsideration before the Commission, and (iii) appeal to any and all appropriate appellate courts.

4. Protestants desire to remain parties of record for the purpose of receiving copies of any orders or secretarial letters issued by the Commission or its staff with respect to the Application, regardless of the acceptance or denial by the Commission or its staff of this Restrictive Amendment and Stipulation of Withdrawal of Protests.

WHEREFORE, the parties, intending to be legally bound, have executed this Restrictive Amendment and Stipulation of Withdrawal of Protests this 29<sup>th</sup> day of July, 2019.
