
On August 1, 2019, it was discovered that Mr. Donald Lauchnor, a Protestant in the above captioned Application case, submitted to the Commission a letter of withdraw of his May 28, 2019 protest. The letter is dated July 19, 2019 but was never date stamped upon arrival, and although the letter was placed in the public folder of the docket, it appears not to have been officially filed with the Secretary. The Commission is accepting the letter of withdraw as part of the record in this docket effective August 1, 2019.

Review of the filing also revealed that no certificate of service or other indication that the Parties of record to the case were served with the withdrawal letter.

Therefore, to satisfy due process concerns, the letter is also being served upon the Parties in this case to constitute service for purposes of 52 Pa. Code Section 1.54. Both the withdraw letter and this Secretarial Letter will be placed upon the record at the above docket number.

The Secretarial Letter will also serve as notification to the Bureau of Technical Utility Services and the Office of Administrative Law Judge that Mr. Lauchnor's protest to the Application has been withdrawn.


