Pursuant to the Interim Order Requiring the Filing of a Status Report dated June 25, 2019 ("Order"), I submit this status report.

The original interim order I received that was entered on November 28, 2018, established an "initial litigation schedule" that was impossible to meet for various reasons. On December 10, 2018, I filed a motion to adjust the initial litigation schedule. I never received a response from either the Pennsylvania Public Utility Commission ("PUC") or Duquesne Light Company ("DLC") concerning my motion to adjust the initial litigation schedule.

On March 4, 2019, I filed an amended complaint that includes a detailed timeline of my communications with PUC and DLC. I never received a response from PUC concerning my amended complaint.

Concerning the June 25 Interim Order Requiring the Filing of a Status Report, I prefer a telephonic hearing. Overall, an October hearing presents scheduling problems for me. Family and work obligations require me to travel twice during that month. Both trips involve more preparation than the norm.
