

On Wednesday July 31, 2019, the Parties to the above-captioned proceeding filed a Joint Petition for Approval of Settlement ("Joint Petition") in this matter. On August 12, 2019, the Recommended Decision ("R.D.") of Presiding Administrative Law Judge Eranda Vero was served on the Parties. 
