RULES AND REGULATIONS

RESERVATIONS:

ADVANCE RESERVATIONS MUST BE MADE PRIOR TO THE SERVICE BEING RENDERED. ADVANCE RESERVATION REQUEST MUST BE MADE NO LATER THAN 8 (EIGHT) HOURS PRIOR TO THE TIME OF NEED ON THE CALENDAR DATE OF SERVICE FOR MONDAY THROUGH FRIDAY SERVICE. ADVANCE RESERVATION REQUEST MUST BE MADE NO LATER THAN 24 (TWENTY-FOUR) HOURS IN ADVANCE OF THE CALENDAR DATE OF SERVICE FOR SATURDAY SERVICE.

MILEAGE:

FLAT RATE, CHARGES BEGIN AND END FROM THE CUSTOMER'S POINT OF PICK UP TO THE CUSTOMER'S POINT OF DROP OFF.

AVAILABLE HOURS OF SERVICE:

PARATRANSIT SERVICES WILL BE AVAILABLE BETWEEN THE HOURS OF 7:00 AM AND 6:00 PM, MONDAY THROUGH FRIDAY, AND BETWEEN THE HOURS OF 8:00 AM AND 4:00 PM ON SATURDAY, BY AN ADVANCE RESERVATION REQUEST.

ADDITIONAL EXPENSES:

TOLLS, PARKING/ENTRANCE FEES AND OTHER OUT OF POCKET EXPENSES WILL BE THE RESPONSIBILITY OF THE CUSTOMER AND ADDED TO THE CUSTOMER'S CHARGE.

DEPOSIT RULE:

CARRIER REQUIRES A DEPOSIT OF NOT MORE THAN 20% OF THE QUOTED CHARTER PRICE. FORFEITURE OF DEPOSITS IS WITHIN THE FOLLOWING LIMITATIONS:

- 1) FORFEITURE OF NOT MORE THAN 50% OF THE DEPOSIT IF THE CHARTER IS CANCELLED BY THE CUSTOMER MORE THAN 15 (FIFTEEN) BUT LESS THAN 30 (THIRTY) DAYS PRIOR TO THE DATE THE TRANSPORTATION WAS TO DEPART, AND
- 2) FORFEITURE OF NOT MORE THAN THE TOTAL AMOUNT OF THE DEPOSIT IF THE CANCELLATION OCCURS WITH 15 (FIFTEEN) DAYS PRIOR TO THE DATE THE TRANSPORTATION WAS TO DEPART.

ONE ROUND TRIP/PER ONE DAY MONDAY THROUGH FRIDAY (PICK UP TO DROP OFF AND RETURN)	\$15.00
ONE ROUND TRIP/PER ONE DAY SATURDAY (PICK UP TO DROP OFF AND RETURN)	\$20.00
MONDAY THROUGH FRIDAY (5) ROUND TRIPS (PICK UP TO DROP OFF AND RETURN)	\$35.00

WAIT TIME AT ORIGIN (PICK-UP):

THERE WILL BE NO CHARGE FOR THE FIRST 5 (FIVE) MINUTES THAT THE CARRIER MUST WAIT FOR A CUSTOMER BEYOND THE SCHEDULED PICK-UP TIME. ANY ADDITIONAL WAITING TIME WILL BE CHARGED AT THE RATE OF \$3.00 FOR EACH 15 (FIFTEEN) MINUTES OR ANY FRACTION THEREOF.

WAIT TIME DURING TRIP:

IF CARRIER IS REQUESTED TO WAIT FOR A CUSTOMER AT A DESTINATION OR DURING THE TRIP, THERE WILL BE AN ADDITIONAL WAITING TIME CHARGE OF \$5.00 PER 15 (FIFTEEN) MINUTES OR ANY FRACTION THEREOF.
