By way of introduction, my name is Merrill Mangalasseril, Principal and 100% owner of TMGES, INC.

On August 7, 2019, we were in receipt of a notification that our application (of TMGES, INC.) for approval to supply electric generation services to the public in the Commonwealth of PA was missing the following information:

- The Proofs of Publication must be in their original form because it is required for us to have notarized original affidavits with original signatures.
- "DBA Ananta Energy Source" must be removed from the Surety Bond because the applicant has stated that it will not be using a fictitious name
- The expiration date of the Surety Bond does not make logical sense.
- The Principal [on the Surety Bond] of TMGES, INC., does not have an original signature.





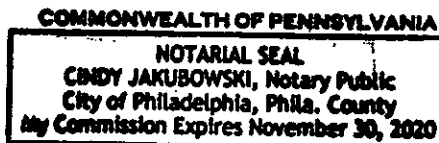
