Rules and Regulations

1. ADVANCED RESERVATIONS

For all passengers, advance reservations are required and must be made at least one (1) business day prior to service being rendered.

2. RATES

For all passengers, rates for mileage are determined by the odometer of the vehicle in use and begin when the vehicle leaves the passenger's premises and end when the vehicle arrives at destination. Rates for return mileage will begin when the vehicle leaves the destination premises and ends when the vehicle arrives at the passenger's premises.

3. ADDITIONAL EXPENSES

All bridge, road and tunnel tolls, parking/entrance fees and other out-of-pocket expenses will be the responsibility of the customer and added to the customer's charge

Expenses for lodging and meals for the driver while on trips out of town which are in excess of 10 hours will be added to the basic charge.

4. HOLIDAYS

Services will not be rendered on the following holidays:

New Year's Day, Memorial Day, July Fourth, Labor Day, Thanksgiving Day, Christmas Day.

5. CONTRACTS

Contract services will be for a term of not less than 30 days for pre-qualified persons under a federal, state, county or municipal government agency contract. Rates for the services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.
