PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully requests a continuance of the hearing scheduled for September 3, 2019, in the above-captioned proceeding until January 7, 2020, so that the parties have additional time to engage in discovery and settlement discussions.
