Dear Secretary Chiavetta:

We represent Ms. Hendin in the above-referenced matter. Pursuant to the August 14, 2019 Interim Order, we submit this status report on behalf of Ms. Hendin. Counsel for the parties have agreed to an in-person evidentiary hearing in Harrisburg, with the exception of Dr. Kracht who will appear by telephone at the hearing. Counsel for the parties have conferred about consecutive days in December for a two-day evidentiary hearing. We are available on December 12th and 13th or December 19th and 20th. Counsel for respondents have indicated December 3rd and December 6th are available, and we understand that as of this afternoon, are pursuing additional dates. We anticipate identifying a mutually agreeable December date.

Our last status update inadvertently indicated that we had served the testimony of Ms. Hendin in January rather than the summary of testimony. We anticipate serving that testimony and Dr. Carpenter's testimony pursuant to the August 14, 2019 Order.
