ISSUE:

Administrative Law Judge, Jeffrey A. Watson has issued an Interim Order dated July 29, 2019 demanding that joint or individual status reports be filed with the PUC by August 16, 2019.

The order states in pertinent part: "That on or before August 16, 2019, the Parties shall file a joint status report or each Party may file an individual status report specifically detailing the extent of compliance by the Parties with the Order entered on June 19, 2019. The status report(s) shall be served upon the opposing Party and the undersigned Presiding Officer. In addition, Complainant shall confer and determine if she wishes to have the hearing scheduled as an in-person in Harrisburg or telephonic hearing, and select dates in which she and her witness are available on October 1-2, 8-10, 15-16, and 22-24, and file a status report, providing a copy to the undersigned Presiding Officer and opposing



5. Complainant was forced to reply to this letter on July 24, 2019.

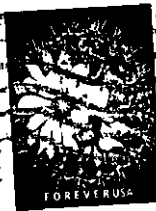
