Dear Secretary Chiavetta:

On July 11, 2019, the Pennsylvania Public Utility Commission ("Commission") entered an Order approving the above-captioned Application filed by The York Water Company ("York Water" or the "Company"). Ordering Paragraph 5 of the Order directed the Company to provide written notification to the Commission within 10 days of the Closing with Jacobus Borough Sewer Authority.

On August 29, 2019, York Water attempted to file a letter providing notification to the Commission that the Closing took place on August 29, 2019. The Company tried to file the letter by both e-file and regular mail. York Water subsequently received notice that its e-filing was being rejected, due to the duplicative copy being filed by regular mail. However, it is my understanding that the Commission does not have the August 29, 2019 letter in its files.

Therefore, enclosed is a copy of the August 29, 2019 letter providing notice that the Closing with Jacobus Borough Sewer Authority has occurred.
