This office represents STAT Medical Transport, LLC ("STAT") with respect to the above referenced matter. I am in receipt of the July 23, 2019 Complaint. I respectfully request that this correspondence be treated as an answer to the Complaint.

On or about July 4, 2019 STAT's insurance was cancelled as a result of non-payment.

However, on July 29, 2019, STAT received a Reinstatement Notice (the "Reinstatement Notice"). The Reinstatement Notice provides that "You recently received a notice advising this policy was being cancelled effective 07/04/2019. This notice is to advise that the policy is being reinstated without lapse of coverage." A true and correct copy of the Reinstatement Notice is attached hereto as Exhibit A.

STAT realizes importance of maintaining requisite insurance coverage and recognizes serious nature of the cancellation of insurance coverage. There has never been a prior instance of STAT ever having an insurance policy cancelled and they do not intent on having it ever happen again.

In light of STAT's history of compliance and the reinstatement without any lapse in coverage, STAT respectfully requests that this matter be withdrawn without a fine or penalty.


