In accordance with the Interim Order issued on August 13, 2019 in the above-referenced matter, this letter serves as a status report on behalf of Metropolitan Edison Company ("Met-Ed") with regard to the anticipated evidentiary hearing. The parties have agreed that an in-person hearing would be preferred given the number of witnesses for both parties and the preferred location for the in-person hearing is Harrisburg, Pennsylvania.
