This letter was sent to Judge A. Watson, Met-Ed & PA PUC.

To: Administrative Law Judge Jeffery A. Watson:

I'm writing about the enclosed letter, which is incorrect. I was told that my evidentiary hearing was to be this month (Aug. 2019). I spoke to your office 3 times & received my letter about the hearing that was to take place this month of Aug. 2019. I sent you 5 copies & originals of my case as requested. I sent Met-Ed & the PA PUC each a copy as requested. I did not change or cancel this Aug. date for the hearing. I've been looking forward to this date & planning for it. So, I expect it to go on as planned this month with a 2 day court phone conference. (I upheld my end & the court should uphold their end.) For 2 1/2 years Met-Ed has changed & changed & changed dates so they don't have to make settlement with me. They keep dragging it out. It's not lawfully to keep denying me my settlement year after year. Everytime I show Met-Ed proof such as I just sent you and Met-Ed & the PA PUC. for my evidentiary hearing this month, Met-Ed gets scared, because they know I have a good (perfect) case against them and they reschedule, without my permission ever. I did not call off or reschedule this months hearing. So, now Judge Jeffery A. Watson after 2 1/2 years of dragging out my settlement, and after 3 failed tries for settlement (once by myself, once thru the Attorney Generals Office & once thru the PA PUC as well as the case appearing in court & you giving me the right to go on with my case blamasking to give me relief by having Met-Ed make settlement with me at our Evidentiary Hearing this month of (Aug 2019). And have this matter come to an end. Met-Ed has lost already 2 of their original 3 witnesses & the 1 that is left can participate in this Aug. Evidentiary Hearing, but will not be able to disprove my findings since they are absolute proof with truth.

Met-Ed has stolen 2 1/2 precious years of my life - and they have known since day 1 that I live in heart failure everyday &

have bad asthma. My heart doctor even put his concerns about the stress Met-Ed & the Smart Meter Case was having on me (medical record with concern ^{in your incidental report} enclosed). Only you can put this harassment to an end and keep my 2 days in court this month as planned. The Law and public justice should protect my rights. Met-Ed has committed Intentional Interference with my personal Rights and Health. They have misled the Legal Process & made a mockery out of it. They've kept me in the Legal System for 2 1/2 years with their lies, just hoping that I'll quit under their pressure and tactics, just because they know I'll win the case with all my knowledge & truth.

Our forefathers established a Constitution to protect all of us from the extremes of human reason. Tyrants like Met-Ed are controlled by the Law (or at least are supposed to be). Our Freedom is given to ^(us) me by the Rule of Law! And right now Met-Ed is trying to take my Freedom away!

Met-Ed has taken the 14th Amendment - Section 1 - #41 and thrown it out the window! It states Interference with Your Person - I have a right to be free from bodily injury, however slight. I have a right to freedom from threats & injury & suffering & distress both physical & mentally. Yet for 2 1/2 years they have caused me overwhelming stress - which affects my heart & my asthma (Stress is the #1 cause of my Asthma ^{attack}). And it will not stop until Met-Ed makes settlement with me this month (Aug 2019).

Do you know what a Adhesion Contract is? It heavily ^(Met-Ed) resists one party (me) while leaving the other free with all the bargaining power. And the only one to stop that is the Judge.

The threats going on in the U.S. by Met-Ed are reminiscent of Nazi tactics used by the Gestapo back in 1930-1940's when freedom of choice was being replaced with dictatorial Law. The fear that some sort of Nazi like tyranny is coming has spread across this Country. The Electric Companies are working hard to try to create the illusion that Smart Meters are mandatory,

that any choice to opt out is not permitted and the Constitution is no longer valid. But, this is not true and I proved Met-Ed wrong in anything they say, it's in my report I sent you. But, Met-Ed doesn't want the Court to hear my report.

* I now plead to the Judge Jeffery A. Watson to arbitrate this case on the Basis of what I have presented to you & Met-Ed & the PA. PUC. this month (Aug 2019) and make a Binding Settlement. I'm entitled thru the law with this relief. My Life is truly on the line. Let the relief start now! Please!

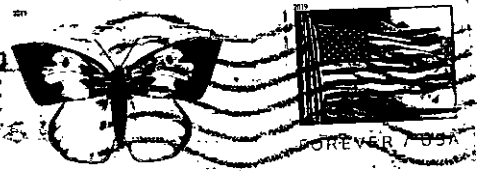

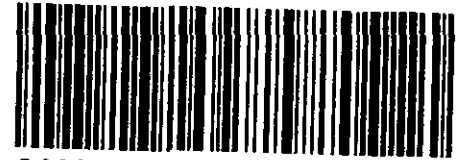
