

In accordance with the Interim order establishing revised litigation Schedule issued by Judge Watson on August 16<sup>th</sup>, 2019, Complainant files the following Status Report.

1. Complainant is still waiting to receive pending answers from Respondent to her Interrogatory Set I- Discovery request 22, as ordered by Judge Watson, first on his interim order issued on May 13<sup>th</sup> and May 24<sup>th</sup>, 2019 and again on his interim order issued on August 14<sup>th</sup>, 2019. As stated in the interim orders, Respondent is to provide full and complete responses to answer this discovery question.
2. In accordance with the interim order of August 16<sup>th</sup>, 2019, Complainant is working on her filing to be sent by September 6<sup>th</sup>, 2019, informing Respondent in writing of any Factual or Expert witnesses the Complainant intends to use. 4. As of this time, Complainant would most likely prefer an evidentiary hearing to be scheduled over the phone, but would like the possibility of an in person hearing to remain open.


