Your Honor,


As I am preparing to file my testimony and exhibits, and the testimonies of others pertinent to my case, I realize I have no assurance my family's private medical information will be kept confidential. I am not submitting the testimonies and exhibits at this time until I can be certain of confidentiality.

Even though our medical records are protected by HIPAA, as to medical providers and their business associates, it is not protected if disclosed to outsiders unless there is a confidentiality agreement in place. I have asked West Penn Power to protect and to keep my family's confidential medical information confidential and they have not agreed to that request. It is only because West Penn Power requested our confidential medical information in the formal complaint process that such a protective agreement is necessary.

If West Penn Power will not safeguard my family's private health information, I am under no obligation to allow them access and West Penn Power will have to take my word for it that the installation of a "smart" meter will harm me and my family. I previously sent a Stipulated Protective Agreement to West Penn Power to sign, but to date, the completed form has not been returned to me.

Therefore, Your Honor, I am requesting a Protective Order be entered to protect my family's confidential medical information.




