This is to advise you that the B & O Railroad Company was ordered by the PUC to paint the Fifth Street viaduct in Ellwood City. On June 1, 1981, the B & O submitted a petition for re-hearing regarding the painting, and as of this date, a decision has not been made.

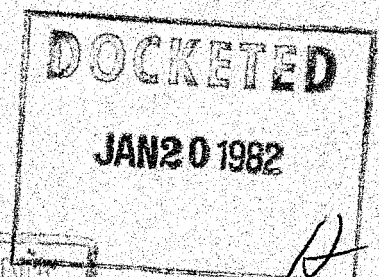
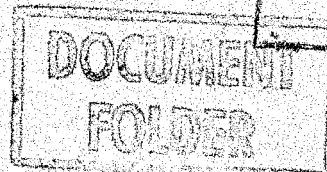
