PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully requests that the hearing scheduled for October 16, 2019, in the above-captioned proceeding be rescheduled for October 17, 2019, at 9:00 AM, because one of PPL Electric’s expert witnesses, Dr. Christopher Davis, is not available for the hearing on October 16, 2019.

On August 16, 2019, I sent an email to Alan Andrews (“Complainant”) about, among other things, rescheduling the October 16, 2019 hearing. On September 17, 2019, I sent another email to the Complainant about the Company’s need to reschedule the hearing. Subsequently, the Complainant and I exchanged multiple emails trying to find a mutually-agreeable date for the rescheduled hearing. Most recently, on October 9, 2019, I sent the Complainant an email asking whether he could attend a hearing on October 17, 2019, at 9:00 AM, which recently opened up as an available hearing time. On October 10, 2019, the Complainant replied via email, stating that he and his wife will be in Canada on October 16 and 17, 2019. Therefore, the Complainant is not available on either of those dates. However, the Complainant asked whether there were any available hearing dates in early February 2020. I subsequently asked whether the Complainant would be available for a hearing on February 6, 2020. As of filing this letter, I have not heard back from the Complainant.

Accordingly, PPL Electric respectfully requests that the October 16, 2019 hearing be rescheduled for February 6, 2020.
