

We are pleased that Regional Resources Energy Group, LLC has applied for a license to provide natural gas services on the Peoples Group of Companies. Specifically you have requested to be licensed as a supplier on the distribution systems of Peoples Natural Gas Company LLC, Peoples Natural Gas Company LLC – Equitable Division, and Peoples Gas Company LLC (formerly Peoples TWP) (“the Companies”).

Since Regional Resources Energy Group, LLC is not currently serving customers on the Peoples systems, we have determined at this time that Regional Resources Energy Group, LLC does not need a bond or other financial security requirement to provide these services to the Company’s customers.

If a Pool is established, and customers are enrolled which alters the creditworthiness requirement or the Company’s exposure to Regional Resources Energy Group, LLC provision of services on the Peoples’ system changes in the future, the Companies may deem it appropriate to require a bond or other financial instrument.


Dear Regional Resources Energy Group, LLC:

PECO is aware that Regional Resources Energy Group, LLC has applied for a license to provide brokering and consulting services to commercial and industrial customers on the distribution system of PECO.

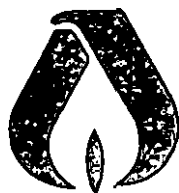
In making such an application, Regional Resources Energy Group, LLC could be required to provide to PECO a bond or other acceptable financial security in an amount that PECO determines to be appropriate. Regional Resources Energy Group, LLC has indicated that it intends to provide only brokering and consulting services to commercial and industrial customers, and will not take title to any delivered natural gas; nor will accept any customer payments or deposits. Therefore, PECO has determined at this time that Regional Resources Energy Group, LLC does not need a bond or other financial security requirement, since they are not directly engaging in business with PECO and only providing brokering or consulting services to PECO customers. However, if the services provided by Regional Resources Energy Group, LLC the creditworthiness requirement for PECO's exposure to Regional Resources Energy Group, LLC changes in the future, PECO reserves the right to require Regional Resources Energy Group, LLC to provide a bond or other financial security instrument.

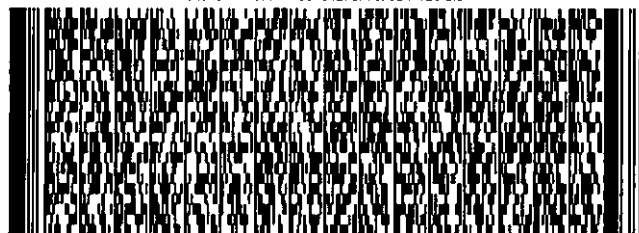
