In accordance with the Interim Order issued on June 28, 2019 in the above-referenced matter, this letter serves as a status report on behalf of West Penn Power Company ("West Penn"). The Interim Order indicates that it is anticipated that an in-person evidentiary hearing will be scheduled in November of 2019 and will be held on two consecutive days in Harrisburg. Unfortunately, West Penn's witnesses are not available for an in-person hearing in November 2019. As such, West Penn agrees with Mr. Bazan's suggestion that hearings be held after January 1, 2020. In light of that recommendation, West Penn is consulting further with its witnesses and will provide an updated status report by the end of this week.

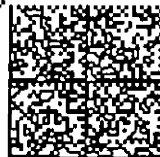
