Pursuant to the Interim Order issued by Administrative Law Judge Jeffrey Watson issued on September 23, 2019, counsel for the Pennsylvania Electric Company ("Penelec") and one its witnesses are available on December 5, 10, 11, 12, 16 and 18, 2019 for the rescheduled telephonic evidentiary hearing. However, its remaining two expert witnesses do not have availability that match the dates provided in the Interim Order. 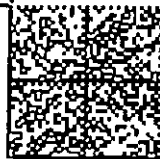
