In lieu of the applicable rates provided for in Tariff Freight PA. P.U.C. Nos. 50-T and 51-W for the above carrier, the following charges and provisions shall apply for shipments between all points in Pennsylvania transported distances of forty (40) miles and less and in excess of forty (40) miles.

**▲ RULE 1 - WAIVER OF MINIMUM CHARGE - CARRIER CONVENIENCE:**

Carrier shall not assess a minimum charge (number of hours) whenever a move requires less than the minimum number of hours filled and said move is performed solely at the carrier's convenience. In such instances, the carrier shall charge based on the actual time required to complete move plus applicable travel charge.
