In accordance with the Interim Order issued on June 10, 2019 in the above-referenced matter, this letter serves as a status report on behalf of West Penn Power Company ("West Penn"). West Penn initiated discovery on June 17, 2019. Mr. and Mrs. Altman failed to respond to West Penn's discovery. On July 25, 2019, West Penn filed a Motion to Compel which remains pending.

Further, Mr. and Mrs. Altman have failed to provide notification of their expert and factual witnesses in accordance with the June 10, 2019 Interim Order. West Penn timely provided notice of its expert and factual witnesses. At this point, West Penn believes that a ruling on its July 25 Motion to Compel is appropriate. Further, it may be valuable for a prehearing conference to be set for this matter in order to determine Mr. and Mrs. Altman's intent in moving their complaint forward.
