Here below are my Response to Preliminary Objections:

My service was never Shut Off at 4756 Loring Street, Philadelphia, PA. When I left I called PECO Energy and told them that I would like my service to be shut off due to me moving and not needing service.


When I moved into the resident located at 6064 Vince Street 2<sup>nd</sup> floor. It was over a year when I called PECO Energy to have service turn on at this location in my name. PECO Energy would not turn the service on; but the service was already on prior to me getting there. Later I receive a ten day notice for me to have the service switch over into my name. The shut off notice did not have any account numbers on it, it was all 0 and it said that I had to pay \$900.00 sum dollars in order for them to put it into my name. I went to a agency called, (we never said never); I was told at the agency that I had to pay \$40.00 sum dollars and they would pay the rest. My service was then put into my name. This information was address; the last time I was in Court and the shut off notice was used as one of the Exhibits. PECO Energy would not give me service until that was paid. I also went to USAF and Crisis to get help with my bill back in 2017 and they paid a total of \$ 900.00 sum dollars. I do not owe all this money that they are saying. Could you please retrieve the documents from the prior hearing

When I moved into the resident on 429 Main Street Apt 1<sup>st</sup> Front Darby PA.

19023. I had my service shut off at 6064 Vine Street 2<sup>nd</sup> Floor on Tuesday 6/5/2018 at 2:15pm. I spoke to a girl by the name of Latoya who told me it would take three day; I asked Latoya did she have anything sooner and she said the earliest she could do would be Thursday 6/7/2018. I said ok and the call was ended on 2:21pm and that I will receive my final bill in a couple months .

I moved into the property at 429 Main Street, Apt 1<sup>st</sup> Front Darby, PA. 19023 on Friday 3/8/2019 three months into my stay my service was shut off on Tuesday 6/4/2019 at around 10:00am. I did not receive any bills until my service was shut off. I called PECO to get the amount of my bill for April and May so that I could pay to have my service restored and was told that I had to pay \$2,553.64 and spoke to a guy by the name of Christine from the collection department who said I owe \$2,662.49. I asked how much I owed for the month of April; I was told \$132.45 and my bill for May was \$34958. The documents that was presented to the Courts are falsify documents that were altered and fabricated This has been a tremendous burden. I would like to get information on where I need to go to file for punitive damages and deformation of character.
