PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) respectfully submits this letter in response to Trent Nickels’s (“Complainant”) October 28, 2019 letter requesting that the November 5, 2019 hearing be rescheduled for “Tuesday, January 14, 2020.”

PPL Electric objects to the Complainant’s request to continue the November 5, 2019 hearing. This proceeding was initiated nearly eight months ago when PPL Electric was served with the Formal Complaint on March 1, 2019. Furthermore, this is the Complainant’s second request for continuance, and it simply reiterates the same reasons for a continuance that were provided in support of the Complainant’s first request.

Nevertheless, if the hearing is rescheduled for January 14, 2020, PPL Electric respectfully requests that the hearing be scheduled to start at 9:00 AM. The hearing in the case *Ulmer v. PPL Electric Utilities Corporation* at Docket No. C-2018-3003824 is scheduled to start at 11:00 AM on that date. Further, although the hearing in *Toffey v. PPL Electric Utilities Corporation* at Docket No. C-2019-3006931 is currently scheduled for 9:00 AM on January 14, 2020, an Initial Decision granting PPL Electric’s Motion to Dismiss the Complaint in that case was issued on October 7, 2019, and no Exceptions challenging that Initial Decision have been filed. Therefore, the Company considers the 9:00 AM timeslot on January 14, 2020, to be available.
