

Your Honor,

I received a letter from West Penn Power Company on November 4, 2019, dated November 1, 2019, concerning my direct testimony not being presented. There are several circumstances I would like for you to consider in this matter.


I sent West Penn Power a Stipulated Protective Agreement on March 2, 2019. West Penn Power has had an opportunity to work out a protective agreement since receiving this document, but willfully chose not to do so.

On October 24, 2019, Your Honor entered a Protective Order in the above-referenced matter. West Penn Power has not acknowledged your order by filing a signed agreement to date. The only signed protective document they provided was their Petition for Protective Order, which is worded differently from your Protective Order. I would like to receive a signed copy of Your Honor's Protective Order from West Penn Power Company for my records in this proceeding.

We have had an unusually difficult time lately with the care of our disabled son as his caregivers 24/7 and we have done the best that we can under the circumstances as pro se. I have just completed the written testimony and I am able to submit it now, but would like to have a signed copy of the Protective Order as explained above. Given that no hearing date has been scheduled, West Penn Power could be given the time needed to provide written rebuttal testimony.

Therefore, Your Honor, I am requesting a signed Protective Order from West Penn Power and that you allow West Penn Power the time needed to produce rebuttal testimony well in advance of a hearing. Please also allow for the time I need to study and reflect on that testimony given my circumstances in regards to the care of my severely disabled son and as pro se.
