Trees caused (29.7%) of outages (9.3% On ROW and 20.4% Out of ROW)

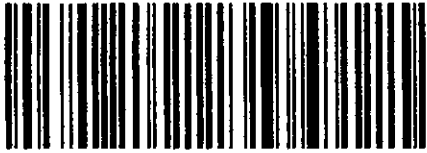
Unknown outages dropped to (18.2%)

The normal yearly trimming cycle was completed for 2019.

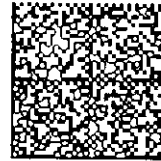
There were three Major Events that the PA PUC allowed for exclusion in July, August and September 2019
